The caller was Garey Simpson at phone number 770-377-7700, and he worked with environmental services, and was hired by the victim/owner of the property. Simpson stated that the owner, John Yardum, phone number 404-885-6222, hired him to keep a check on the property and service the environmental service part of the property that was not in operation. Simpson advised he came to the property on this date, and noticed a white pickup truck that had pieces of tin on the back, that was being stripped and removed from the property and areas around the property. Simpson advised that he was able to take photographs of the vehicle that was leaving the area, however he was not able to get a tag on the vehicle. He described the vehicle as a white in color, 1970's model pickup truck. Simpson stated he called police, because of the problem with subjects coming on the property in the past, taking items of copper and tin from the location. Officers Howell, Wulf, and myself arrived at the location, and drove through the gate that was opened by Simpson. Upon checking the area, we were able to locate two males, identified as James Ware, and David Hardin. Both males were asked why they were at the location, and they stated they were digging for old copper and tin products. Hardin was asked about the white pickup truck that was seen at the location, and Hardin advised that it was his brother, that was later identified as Terry Hardin. David Hardin stated that his brother took a load of the copper/tin items that they collected from the enbankment of the property, to sell it. After speaking with both subjects, they were not allowed to leave the location, until I could further speak with the Simpson.

Upon speaking with Simpson, he showed me photographs that he took of this date, of the white pickup truck driving off the property, with large sheets of metal/ tin, that Simpson advised came from the exterior walls of the abandoned building on the property, and other areas on the property itself. Simpson also advised that there were surveillance cameras on the property that captures certain parts of the property, but he would need to check at a later date to see if he could locate any images of the incident. While speaking with Simpson, I received a call from Officer Wulf, that the white pickup truck returned back to the scene of the location. Simpson advised that the vehicles normally drive around the backside of the property near the power poles, where they can enter without a secured gate. I made contact with the driver, who was being detained. The driver was identified as Terry Hardin, date of birth 02-05-1976. The vehicle was registered to Terry Hardin, at 2202 Spink St. Simpson also drove around to this location and confirmed this truck to be the same truck that was seen leaving the location with the metal tin items on the rear of the truck. I advised all three males subjects that they were being detained for theft by taking. Simpson stated he wished to prosecute the incident on behalf of the victim. I contacted investigator Bahrey and advised him of the incident. All three males were transported to the zone two precinct for processing. The vehicle was impounded by Futos Towing. Upon arrival to the precinct, I also contacted the Fulton County Burglary Task Force of the incident, and they responded to the scene and debriefed the subjects.
